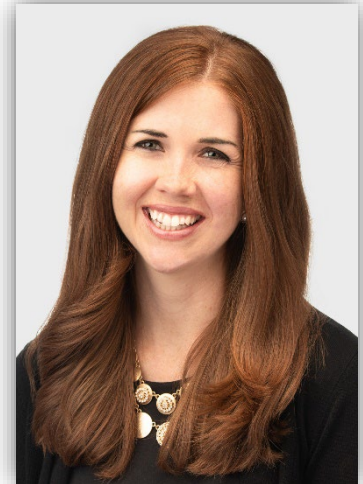
Jennifer Steeve handles high-stakes trial and appellate matters nationwide on behalf of major companies in a variety of industries, including aviation, finance, energy, and technology.
